### ADOPTED EU ACQUIS TRANSPOSITION OF R&TTE DIRECTIVE

- The implementing Regulation on Radio and Telecommunications Terminal Equipment (1999/5/EC R&TTE Directive) was published in the OG dated 11.05.2003.
- The Regulation was discussed in EU-TURKEY meeting with EC representatives on 11.09.2003.
- The Regulation entered into force on 11.05.2004.





### ADOPTED EU ACQUIS IMPLEMENTATION OF R&TTE DIRECTIVE - I

- Due to the implementation of R&TTE Directive, notification form was prepared in accordance with EU TCAM Committee format and published in TA web site.
- Frequency plan was published on TA and EU web sites.
