# The launch of the “new” SCAR

- **1974:** Council Regulation N° 1728/74 establishing SCAR
- **1974-1999:** DG AGRI responsible for agricultural research and management of SCAR
- **July 2004:** SCAR management transferred from DG AGRI to DG Research
- **22 November 2004:** Dutch Presidency report calling for a high-level decision platform: a new role for SCAR
- **End November 2004:** Member State Permanent Representations to nominate two high-level representatives
- **2-3 February 2005:** First “new” SCAR meeting

# SCAR tasks

Main role for SCAR:

**Support the Commission and MS towards better coordination of agricultural research across the European Research Area**

This will involve:

- Strategic discussions on the agricultural research agenda in Europe in the long term (FP7 and beyond)
- Enhanced cooperation between Member States (joint research programmes, common infrastructures)
- Research agenda in scientific support to the Common Agricultural Policy
- Exchange of information with complementary mechanisms under EU Framework Programmes

- **Mapping infrastructures / institutions / activities**
- **Establishment of a permanent SCAR Working Group**
- **Nomination of Observers**

## **SCAR meeting** - *SCAR members*

- High-level decision forum
- Set up and monitor working group
- Consider proposals for action

## **Working groups** - *Nominated ad hoc staff*

- Standing oversight SCAR-WG operate as a think-tank
- Collaborative working groups (CWG) on specific topics

## **Secretariat** - *Commission*

- Preparation of and follow-up from plenary meetings
- Assistance to SCAR-WG

# Towards a Common Research Agenda

## Agreement on priority topics

- Strategic discussions on the agricultural research agenda in Europe based on existing and possible future coordination fora (e.g. ERA-Nets, Technology Platforms, Networks of Excellence)
- Identified areas for possible cooperation between Member States

## Establishment of collaborative working groups (CWG)

- Commitment for coordinating CWGs on 13 themes

## SCAR input to FP7

- Discussion paper on FP7

# Mapping of EU agriculture research capacity

## Mapping infrastructures: a draft paper

- Identification of key-agriculture infrastructures of EU relevance
- Sharing existing infrastructures among Member States research teams
- Targeted proposals for future activities of SCAR
- Links with European Strategy Forum on Research Infrastructure

## Mapping activities: a project

- Building on EU-funded projects from recent calls (e.g. SSP4 “Mapping and foresight of the EU agricultural research capacity”)

## Mapping institutions: a website

- Development of a prototype for a SCAR web portal building on existing EU websites and linking with relevant MS/institution
