- ✓ The Ministry of National Education (MoNE)
- √ National Agency of Turkey (Youth Programme)
- ✓ General Directorate for Social Services and Child Protection (SHCEK)
- ✓ Other related public agencies and NGOs





#### **MAIN ACTORS**

## **General Directorate of Youth and Sport (GSGM):**

- ✓ Responsible for:
  - > Planning, programing, implementing, monitoring youth services out of school
    - Construction of youth centres, hostels, camps and sports fields
  - Organizing courses for improving the abilities and knowledge of the youth
- ✓ GSGM works closely with other related institutions including MoNE and NA

- ✓ Implements youth-related EU Programmes
- ✓ Execution of small scale pilot implementations in various fields
- Establishes contacts with the EU Commission, other national agencies regarding youth

### **Private Sector and NGO's:**

- ✓ Contribute to the public policies
- ✓ Promote the participatory mechanisms
- ✓ Follow the international agenda
- ✓ Increase the resources allocated to the youth



### **COMPLIANCE WITH THE EU**

#### **PARTICIPATION:**

- ✓ Establishment of youth councils in each municipality became a legal obligation
- ✓ Efforts for the establishment of a National Youth Parliament continue
- ✓ The GSGM endeavours for promoting the participation of young people in the social life via the youth centres.

#### **EMPLOYMENT:**

The Government envisages pre-cautions for the enhancement of youth employment and entrepreneurship under the programmes stated below:

- ✓ The Entrepreneurship Programmes of Small and Medium Sized Industry Development Organization (KOSGEB)





### **COMPLIANCE WITH THE EU**

### **GETTING MOST OUT OF BEING YOUNG**

- ✓ Non-discriminatory implementations regardless of sex and disability
- ✓ National Policy Documents include pre-cautions for avoiding drugs and improving mental and physical health of youth
- ✓ Information programmes on sexual education at secondary school level
- ✓ Turkey has comparative advantage for the issue of family
- ✓ No prohibition in Turkey in expressing culture
- ✓ Efforts for an effective coordination among the relevant public institutions in the area of social protection of youth continue
